2 sent to jail for making drugs without permit

A LOCAL court in Vadodara sentenced two people, including a pharmacy owner, to one year in simple imprisonment for manufacturing ayurvedic drugs without a permit. The court also slapped a fine of Rs 10,000 on the pharmacy owner, to one year in simple imprisonment for manufacturing ayurvedic drugs without a permit.

The case pertains to a case in 2023 when an official of the Food and Drug Control Administration (FDCA) of Gujarat was probing a doctor in the Anand. The official chanced upon a stash of Ayurvedic medicines during the probe. FDCA is not allowed to manufacture ayurvedic drugs, used in allopathic treatments, in the sample. FDCA seized the ayurvedic drugs to Nizampur-based Divya Ayurvedic Pharmacy from where raw materials are procured to manufacture the drugs were recovered.

SHE STABBED HUSBAND, HERSELF AND SET APARTMENT ON FIRE: COPS Woman with stab wounds asphyxiates to death in burning flat in Ahmedabad

A WOMAN died of asphyxiation, allegedly after she stabbed her husband on himself after stabbing her husband on a light turn in a flat in Ahmedabad Friday. The woman also set her apartment on fire Friday. The deceased woman was identified as Anila and her husband Anil Harbans. She has sustained injuries and is in hospital, police added.

The couple have two children who were said to have been in school at the time of the incident. The Ahmedabad Fire and Emergency Services (AFES) got a call around 10.15 am about an apartment in Eden V block of Godrej Garden City, on Friday. Fire-fighting teams from Thaltej and Chanki reached the site and found the wife lying on the ground floor in a pool of blood. Later, on reaching the fourth floor, where their apartment was on fire, the husband was found lying in a pool of blood," Ahmedabad Divisional

band was fire apart from a few cuts and blood, but was in shock. Both of them were brought to the Sola Civil Hospital. The body of the wife has been taken for the post-mortem, and the husband is being treated in the hospital.

A case of accidental death has been registered. According to VS Vanzara, Inspector at Chanki Thaltej police station said, "As per the preliminary report of the post-mortem, the cause of the wife's death was due to asphyxiation, her lungs were filled with smoke. The death probably happened between 9.59 am to 10.30 am. A complete post-mortem report is yet to come."

The police said that according to Anil, the incident occurred after an argument the two had over breakfast on Friday. "The wife lit a matchstick and her husband, Anil, the husband

Following which she disconnected the gas line in the kitchen in order to kill herself which resulted in the fire. Both Anil and Anika did not have any burn injuries, said the police officer. According to fire-fighter-jack, neighbours called the 108 ambulance and both the man and woman were shifted to Sola Civil Hospital. When the fire department came, nobody was inside the apartment, he added.

A resident of the block who lived on the ninth floor said that she and a few others tried to call the fire department and tried operating the door, but they could not. "After some time, Anil Harbans opened the door. The whole apartment was filled with smoke. And Anil asked me to save his wife," the neighbour said. Pieces of the puzzle fell into place, the police summoned the families of the couple. The couple, engaged for the last three years, were expecting their first baby. A police officer said, "The man and the woman are both aged about 24 years. They live in the same apartment. How they were scared to inform their family members about the pregnancy and were planning to hide it until the wedding. On Thursday, as the man went into labour, the fiance accompanied her to SSG Hospital but she delivered the baby on the way in the auto rickshaw and passed out. In a state of panic, the man abandoned the baby near a vehicle outside the Khamwad crematorium."

The officer said the families accepted that the child belonged to them. "As the woman began to have contractions over the past few days, she told her family that her husband was due to acidity. They claimed the woman managed to conceal the baby bump by wearing loose clothes. We are probing the case," the official said. Officials said the police would accept the bitter families to accept the couple and the child.
