NOTICE is hereby given that the Extra-Ordinary General Meeting (“EGM”) of the Shareholders of **“Vivanta Industries Limited”** (“Company”) will be held on **Tuesday, 7th January, 2025 at 03:00 P.M. “RESOLVED FURTHER THAT, in terms of the provisions of Chapter V of the SEBI ICDR Regulations, the Relevant Date for determining the price for the Preferential Issue of Equity Shares is **Friday, 6th December, 2024** i.e., the date 30 days prior to the date of the Extra-Ordinary General Meeting (“EGM”) (“**Relevant Date**”) on which this special resolution is proposed to be passed.”

“RESOLVED FURTHER THAT, the minimum price of the equity shares so issued shall not be less than the price arrived at in accordance with Chapter V of the SEBI ICDR Regulations. The equity shares of the Company have been frequently traded as on the relevant date and considering that the allotment to the proposed allottee(s) is not exceeding five percent of the post issue fully diluted share capital of the issuer. However, the Body Corporates are entitled to appoint Authorised representatives to attend the EGM through VC/OAVM and participate there at and cast their votes through e-voting.
8. Members of the Company under the category of "Institutional Investors" are encouraged to attend and vote at the EGM through VC/OAVM. Body Corporates whose Authorised Representatives are intending to attend the Meeting through VC/OAVM are requested to Email at compliance@vivantaindustries.com and/ or at evoting@nsdl.co.in, a certified copy of the Board Resolution/ authorization letter authorizing their representative to attend and vote on their behalf at EGM through E-voting.
